**REQUESTING THE REGIONAL LINE AGENCIES (RLAs) AND LOCAL
GOVERNMENT UNITS (LGUs) TO PRIORITIZE THE GENERATION
OF THE SUSTAINABLE DEVELOPMENT GOAL (SDG)
TIER 2 INDICATORS OF ILOCOS REGION**

WHEREAS, during the United Nations (UN) Sustainable Development Summit on September 2015, 193 UN Member States (MS), including the Philippines committed to the achievement of the SDGs;

WHEREAS, the UN Statistical Commission adopted the SDG Indicator Framework wherein this shall serve as the core of all other sets of indicators and MS will develop indicators at regional, National and Sub-national levels to complement the global indicators, taking into account national circumstances;

WHEREAS, the 2030 Agenda for Sustainable Development is a plan of action for people, planet, and prosperity. It also seeks to strengthen universal peace in larger freedom. All countries and all stakeholders, acting in a collaborative partnership, will implement this plan;

WHEREAS, the Philippine Statistics Authority (PSA) Board approved and adopted the initial SDGs for monitoring in the Philippines on May 18, 2017;

WHEREAS, the Regional Statistics Committee I (RSC – I) organized a technical working group for the formulation of the Regional Statistical Development Program for monitoring development indicators such that of the SDGs;

WHEREAS, the TWG spearheaded by the National Economic Development Authority (NEDA) and PSA conducted workshops for the identification, validation, and finalization of SDG indicators for Ilocos Region;

WHEREAS, the RSC – I through RSC Resolution No. 03 series of 2019, approved the SDG Indicators for Ilocos Region covering the Core Regional SDG Indicators (CoRe-SDGIs) and additional SDG indicators from the Regional Development Program Results Matrix considered as Unique Regional SDGIs for Ilocos Region;

WHEREAS, the RSC – I through RSC Resolution No. 05 series of 2020, approved the establishment of the SDG Watch for the Ilocos Region and mandated Philippine Statistics Authority – Regional Statistical and Services Office I (PSA – RSSO I) to compile and maintain an SDG Indicators database, prepare the SDG Watch, and report to RSC – I the updates on the monitoring of Region 1 SDG Indicators;
