**APPROVING THE INCLUSION OF THE COMMISSION ON POPULATION AND  
DEVELOPMENT, OFFICE OF CIVIL DEFENSE, AND PHILIPPINE NATIONAL POLICE AS  
ADDITIONAL MEMBERS OF THE REGIONAL STATISTICS COMMITTEE**

**WHEREAS**, RA 10625 mandates the Philippine Statistics Authority (PSA) to prescribe appropriate frameworks for the improvement of statistical coordination and establish mechanisms for statistical coordination at the regional and local government unit (LGU) levels;

**WHEREAS**, PSA Board Resolution No. 05, Series of 2015 established the Regional Statistics Committees (RSCs) to oversee, formulate, and strengthen statistical policies designed to resolve local statistical issues and provide guidance to regional and local statistical development activities;

**WHEREAS**, under the Article II of the same Resolution, the RSC is allowed to modify its composition to provide flexibility in its operations and expand its representation to other regional line agencies (RLAS), City/provincial Planning and Development Offices (C/PPDOS), State Universities and Colleges (SUCs), and the private sector;


**WHEREAS**, the RSC-1, as the lead committee in statistical policy making and coordinating body, forwards the inclusion of the Commission on Population and Development (POPCOM), in recognition of its role in the coordinating and monitoring of population-related activities, Office of Civil Defense (OCD), in recognition of its important role in the generation and dissemination of disaster-related data, and Philippine National Police (PNP), in recognition of its integral role in the generation and dissemination of data on peace and order;

**NOW, THEREFORE, ON MOTION DULY SECONDED, BE IT RESOLVED** that the Committee approves the inclusion of POPCOM, OCD, and PNP as new and additional members of the RSC-1;

**RESOLVED FINALLY**, that the copies of this resolution be disseminated to the concerned agencies and offices.
